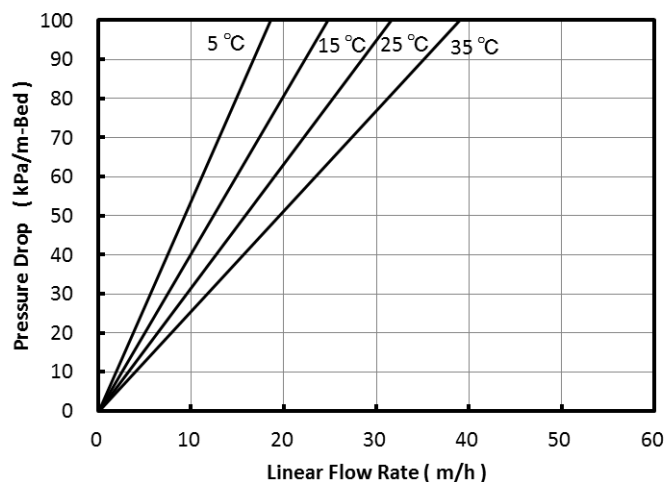


Fig. 1 Pressure Drop of WK10S

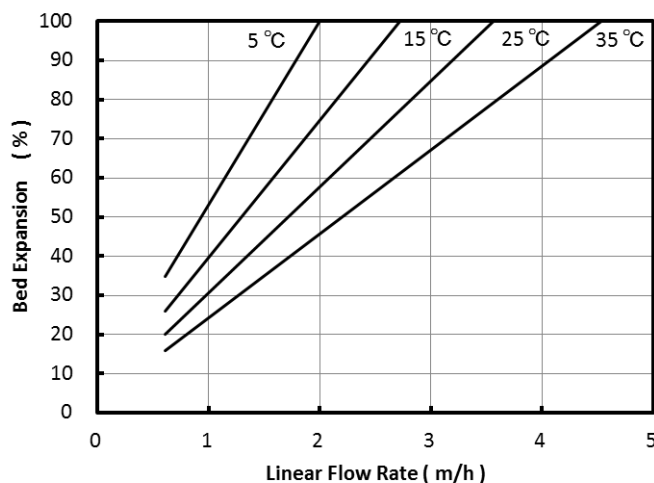


Fig. 2 Bed Expansion of WK10S
